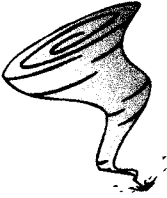
**PLAN AHEAD**

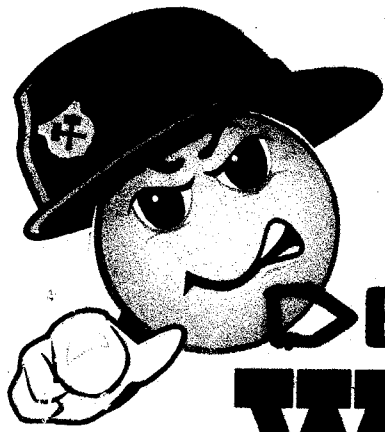
